


Pusan National University Graduate School of Finance has been established in September 2018 with the financial support from the Financial Services Commission and Busan Metropolitan City.

Pusan National University and the Korea Maritime University Graduate School of Finance will give a joint degree with the specific goal of nurturing "global finance specialist with practical abilities". For this purpose, Pusan National University Graduate School of Finance is providing 5 different programs below.

Second, most courses are taught in English to adapt to the global financial environment. The use of English as a common language in the financial industry is a prerequisite for communication and exchange with financial professionals around the world.
